**Passkeys required for the Xero Me app & deleting devices on myID.**



### **Xero Me Passkeys**

Xero has an app called **Xero Me** for employees. The app enables them to submit timesheets, claim expenses, request leave and manage personal details.

To ensure all payroll data in Xero is secure both for employees and business owners, Xero is requiring all employees using Xero Me to set up a passkey. This must be done by **8th September 2025**.

A passkey is either a fingerprint or facial recognition and is used to log in instead of a password.

**Next BAS due date:** The next quarterly BAS for **July to Sept 2025**, is due by **25th November 2025 if lodged online by a tax professional or in Online Services for Business**. If you are receiving a paper BAS and are not an active STP reporter, the BAS is due by **28th Oct 2025**.

**Next IAS due date:** The August 2025 Business Activity Statement is due by **21st Sept 2025**.

**Next Super due date:** The Q1 2025-26 SG is due **by 28th October 2025**.
