TPAR Due Date Extension & SGC Statements Due Today



If you're in the know, you'll be aware that the **Taxable Payments Annual Report** (TPAR) is due to be lodged by today, 28th August.

However, last Friday I received an email from the ATO that states that they will accept lodgements up to **31st August** and treat them as being lodged on time. This is great news if you are running behind and haven't quite gotten to this job!

Start: Friday 25 August 11:30 pm AEST End: Monday 28 August 7:00 am AEST

The due date for Taxable payments annual report (TPAR) is 28 August. If you lodge before 31 August, we will treat it as if it is on time.

Not only is the TPAR due today but so are any **SGC Statements** you may need to lodge.

If you are an employer and you didn't pay your employees' super in full, on time, or to the right fund, you must lodge a Super Guarantee Charge Statement by the 28th August, or penalties may apply. This applies to the June 2023 quarter.

Payment of the SGC Statement fees are also due on 28th August.

ATO SMS and Email Impersonation Scam

The ATO is aware of multiple fake SMS and emails in circulation that are impersonating them. These messages reference ATO refunds, tax return payments, or more simply a general ATO notification. They are directing people to click on a link that directs to a fake myGov sign-in page. See 2 x examples below.

If you, your staff, or your clients receive these communications, do not click on links contained within these messages. The ATO encourages anyone who receives an SMS or email like this to forward the message or email to <u>ReportScams@ato.gov.au</u>, and then delete it.

The ATO will never send a link to log in to online services. These should be accessed by typing <u>ato.gov.au</u> or <u>my.gov.au</u> directly into the browser.
